Day-to-Day Trip Itinerary

Day 1/Sunday, July 9: Transfer and Overnight in Chicago area

Transfer from Davenport to the Courtyard by Marriott Wood Dale, Illinois, near Chicago O’Hare airport with dinner enroute, and overnight with breakfast. (D)

Day 2/Monday, July 10: Fly to Fairbanks and overnight

Breakfast at the hotel; Transfer to Chicago O’Hare airport for flights to **Fairbanks**. Upon arrival we will transfer to the hotel for our two night stay. (B)

Day 3/Tuesday, July 11: Full day of tours in Fairbanks and Pioneer Park’s Alaska Salmon Bake

We will have a fun day beginning with a **city tour** of Fairbanks, as well as a visit to the **Trans-Alaska Pipeline**. You will then be transferred to the **Gold Dredge #8** where you will ride the **Tanana Valley Railroad** through the gold fields of the Interior. Meet Alaskan Gold Miners and pan for gold. Later, you will be transferred to the Chena River for a scenic **riverboat cruise**. Enjoy this three-hour cruise that will take you into the heart of Alaska and introduce you to a family who has made the rivers of Alaska a way of life. You will see a float plane takeoff alongside the boat, visit the home and kennels of the late four-time Iditarod winner Susan Butcher, and see her champion sled dogs in action. For dinner, you’ll enjoy the delicious **Salmon Bake Dinner** at Pioneer Park. (D)

Day 4/Wednesday, July 12: Scenic Domed Rail Journey from Fairbanks to Denali National Park

Transfer to the train depot. Enjoy a scenic ride to **Denali** via the **Wilderness Express Dome Train** in a deluxe dome railcar (approx. 8:15 am – 12:10 pm). Your afternoon will be at leisure to enjoy optional tours such as hiking, flightseeing, mountain viewing or rafting or just relaxing at the Lodge. Overnight at a Denali Lodge for one night.

Day 5/Thursday, July 13: Denali National Park Natural History Tour and transfer to Talkeetna

This morning travel into **Denali National Park** on the **Denali Natural History Tour** given by the Park Service and search the pristine wilderness for Denali’s “big 5” consisting of bear, moose, caribou, wolves, and dall sheep. This four to five hour journey is narrated allowing for insight into the animals, flora and fauna of this spectacular region. Afterwards, time for lunch on your own before tour south to **Talkeetna**. Overnight Talkeetna Alaskan Lodge.

Day 6/Friday, July 14: Scenic journey to Seward including Anchorage city tour; Board the ‘Millennium’

Today, board your motorcoach and enjoy the scenic journey south to the coastal community of **Seward**. Enroute enjoy a brief city tour of **Anchorage**, Alaska’s largest city with time for lunch on own. Also included is a visit to the **Alaska Wildlife Conservation Center** where you will have a chance to see Alaskan wildlife up close. Upon arrival into Seward it will be time to say goodbye to your local tour director and driver as you are transferred to the Seward Cruise Terminal to check-in for your cruise on the ‘*Millennium*’. Day 7/Saturday, July 15: Hubbard Glacier, Alaska

A full day of glacier and wildlife viewing by ship allows you to see and experience the immensity of Alaska and its strong forces of nature. (B,L,D)

Day 8/Sunday, July 16: Juneau, Alaska:

The capital city can only be reached by sea or air, and is home to the Mendenhall Glacier and Visitor Center just north of town. A long day in port allows you to join a fishing expedition for salmon or halibut, take a whale watching cruise, or enjoy an outdoor salmon bake. (B,L,D)

Day 9/Monday July 17: Skagway, Alaska

Walk the wooden sidewalks of this ‘Gold Rush’ town and shop or dine in 1890’s style. Thirteen hours in port allows for several tours, perhaps including an excursion on the ‘White Pass & Yukon Railroad’ steam train which follows the Chilkoot Pass up to the Yukon. (B,L,D)

Day 10/Tuesday, July 18: Icy Strait Point, Alaska

This former salmon cannery, is now the site for many types of land and sea adventures and shore excursions, which will be available exclusively for ship’s passengers. (B,L,D)

Day 11/Wednesday, July 19: Ketchikan, Alaska

This small fishing village in North America's only rainforest is picturesque. Optional tours include the lumberjack show, a visit to a Totem Village or flight-see over Misty Fjords National Park. (B,L,D)

Day 12/Thursday, July 20: Cruising the Inside Passage

A sea day filled with amazing sights along **Alaska's Inside Passage**, and time to enjoy the shipboard amenities and activities. Time to pack up and start to review your many memories. (B,L,D)

Day 13/Friday, July 21: Disembarkation in Vancouver, city tour; Overnight in Vancouver or Seattle

The '*Millennium*' sails into **Vancouver, Canada**. After breakfast, disembark the ship. Enjoy a tour of **Vancouver**, including enchanting Stanley Park. You will then be transferred to your hotel in Vancouver or Seattle (flight dependent) for an overnight stay. (B)
